SINCE SEPTEMBER 2010, Habitat for Humanity has been accepting applications for a housing repair program called **A Brush with Kindness**. This nation-wide program serves low-income families who struggle to maintain the exterior of their homes, and is aimed at providing exterior painting, minor exterior repairs, landscaping, and exterior cleanup to homeowners.

- · Work is done by volunteers using donated materials whenever possible
- Homeowner must meet basic Habitat criteria for selection, including need, willingness to partner, and ability to repay a no-interest loan
- Selected projects have a \$500.00 cap. Payments made by Partner families are placed in a revolving fund to help A Brush with Kindness serve others in need
- The program is designed to encourage connections within the community and help preserve affordable housing stock

Charitable Giving

Brown County Habitat is certainly always interested in volunteers of time and/or the immediate check in the mail, but we would like to point out some other ways Habitat could benefit.

Common Stock You may donate stock from your investment portfolio. Appreciated stock that you may have gains on if you sold can be gifted to Habitat as a charitable contribution making a nice gift to us and eliminating capital gain tax liability.

Land Brown County Habitat can benefit from your gift of land to build a future house. Again this could be a way to move an appreciated asset for a tax deduction without capital gain.

Estate Planning We would be happy if you provided for us in your will. However another thought: Most of us have some type of retirement plan...an IRA or 401K/403B plan at work. It is important to designate beneficiaries, the primary typically being your significant other or children. You can also make a designation of a contingent beneficiary where the dollars would pass if the primary was also gone. That's where a designation to Habitat could provide an interesting way to pass on a portion of the account as contribution upon your death.

IRA Required Minimum Distributions If you do not need the dollars the IRS says you need to withdraw from an IRA consider gifting them to Habitat.

Donor Advised Funds Open an account with a Charitable Endowment Fund. You will get the full deduction for contributions in that year, then direct dollars to qualifying charities when you wish.

As always with any thought of charitable strategies consult with your tax advisor, legal counsel and financial advisor for assistance.
